Sims' Report –

We received the \$156,000 payment from Comcast and will be receiving approximately \$350,000 per year as a result of the .5% PEG fees collected by Comcast.

We are bigining to negotiate a new DAP (Designated Access Provider) agreement with the MTA The original DAP has expired and we renewed for two years with the expectation of a renegotiated contract. We expect to have a negotiated contract prepared for consideration in 4 to 5 months.

• Outreach/Development Committee – updates

Wolpert's Report:

We have between 30 and 35 prospective leads for business sponsorship of the channels. They have all been called, next steps are to go meet and discuss the sponsorship opportunities.

Jonathan Westerling's Report:

CMCM has an \$8,000 advertising budget, the board needs to decide if they want an advertising program and what that would look like. A number of suggested venues were discussed and Westerling agreed to take the first step and get pricing on the different media venues.
